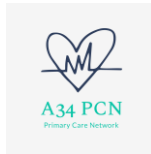
SALARIED ARRS GP – 6 SESSIONS - £12,000/SESSION

Newbury is a thriving Market Town located along the M4 corridor. The region is relatively affluent and benefits from high employment levels. Reading is just a 30-minute drive away and the town and surrounding villages are ideally located for easy access into London, down to the West Country and north to Birmingham, Manchester and beyond.

We are well set up with West Berkshire Community Hospital nearby for walk in x-ray service, outpatient clinics and palliative care beds.

Days of the week worked are negotiable. The day (two sessions) would consist of 25 patients face to face in line with BMA safe working and 1 visit if needed. Visit rates are low. The patients will be a mix of acute and routine patients, with a preference for acute. You will not be holding a list or being duty doctor.

All three practices use EMIS. We're ably backed up by our PCN Manager and the three Practice Managers.

You must have completed your training within the last two years and are not currently or have not previously been employed in a substantive post.
